

## **Centre Determined Grades Appeals Policy**

There are two levels of appeal/review which can be carried out at school level:

- 1. Appeals against results
- 2. Appeals against decisions in respect of access arrangements, reasonable adjustments and special consideration

An appeal may be submitted by a pupil if they believe:

- 1. A marking or moderation error has occurred or
- 2. The school/ department/ teacher did not apply its procedures consistently, properly or fairly.

If you are unsatisfied with the process used to determine your grade and wish to appeal, follow the steps below:

- 1. Speak to the relevant teacher in relation to the final grade.
- 2. Speak to the relevant Head of Department in relation to the final grade.
- 3. If you are unsatisfied with this, please speak to the relevant Head of Department about the evidence used to determine the final grade.
- 4. If you are unsatisfied with this, you can complete a written request for a Centre Review Appeal by completing the Centre Review Application form (which is available from Mr Manson and on the College website).
- 5. The closing date for all internal appeals/review is 17<sup>th</sup> Sept 2021.
- 6. Mr Manson will then complete a review of the information and inform the student of the decision.
- 7. Following this Centre Review, if you are unsatisfied you can also apply for an appeal/review of your grade with the Awarding/Examining Body on the grounds of academic judgement (unreasonableness). Please refer to their website for further details. Applications for this should be sent to Mr Manson who will pass on any further documentation/communication to the Awarding Body.
